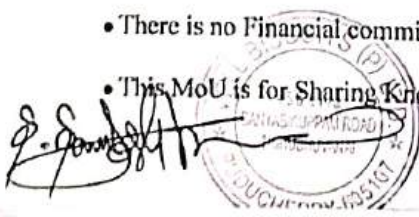
The terms and Conditions of this MoU are hereby acknowledged and accepted by each of the parties.


